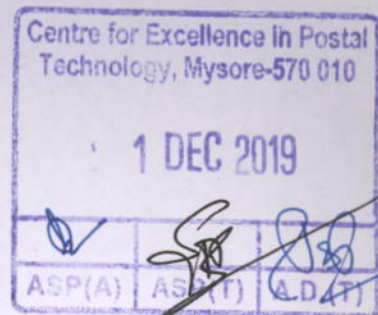

Eligibility Criteria:-

In addition to minimum educational qualifications mentioned above, the following categories of sports persons are eligible to apply.

1. Sports persons who have represented the country or state in an International or National competition in any of the games mentioned above.
2. Sports persons who have represented their Universities in the Inter University tournament conducted by the Inter University Sports Board in any of the games mentioned above.
3. Sports persons who have represented the State School team in the National Sports / Games for Schools conducted by the All India School Games Federation in any of the games mentioned above.
4. Sportsmen who have been awarded National Awards in Physical Efficiency under the National Physical Efficiency Drive.

(Those sports persons who fulfill the above criteria are eligible to apply. Preference will be given to those sports persons who have active participation in the above level in order of preference i.e., International/ National/ Inter University/ National School of Games/ National Physical Efficiency Drive and secured positions.)

Age:-

1. For the post of P.A/S.A/ Postman/Mail Guard, age limit is between 18 to 27 years as on **06.01.2020**. Relaxation in age up to a maximum of 5 years for UR (08 years for OBC candidates & 10 years in case of SC/ST candidates) shall be considered for eligible candidates for the purpose of recruitment of posts specified.

2. For the post of MTS, age limit is between 18 to 25 years as on **06.01.2020**. Relaxation in age up to a maximum of 5 years for UR (08 years for OBC candidates & 10 years in case of SC/ST candidates) shall be considered for eligible candidates for the purpose of recruitment of posts specified.

How to Apply:-

Applicants are required to submit their applications in the prescribed format dully filled in by him/her along with the following documents **duly attested by a gazetted officer:-**

1. Certificates in support of educational qualifications.
2. Proof of Date of Birth (Birth Certificate or 10th Board Certificate with DOB) .
3. Certificates issued by the competent authorities in support of sports achievements in the disciplines mentioned in the table.
4. Certificates showing relevant positions in Cricket Discipline(Batsman), if applicable.
5. For claiming relaxation in age, attested copy of recently issued Caste Certificate by competent authority in case of SC/ST candidates.
6. Two recent passport size photographs self-attested.
7. Self attested copy of one ID proof i.e, Voter ID/PAN Card/Passport/Driving License/ Aadhar Card.

The envelope containing complete application along with all documents must be superscribed as follows:

“APPLICATION FOR THE POST OF UNDER SPORTS QUOTA INDISCIPLINE”

Applications received in any of the following format will be rejected.

1. Incomplete application form.
2. Without photographs.
3. Without full signature in appropriate place.
4. Name of post & discipline on the envelope & application form.
5. Without documents.
6. Applications received after due date.

It may be noted that one candidate can apply for one post & one discipline only. If any candidate found applying for more than one post or more than one discipline, his/her candidature will be rejected.

Applicants already in service should apply through proper channel failing which their applications are liable to be rejected.

Selection of the outstanding sportspersons for recruitment of different cadres will be made as per the instructions issued by the Govt. from time to time.

Chief Postmaster General, Odisha Circle, Bhubaneswar reserves the right to reduce the number of vacancies as notified or cancel the selection at any stage without assigning reasons whatsoever.


